On September 14, the League hosted the East Lansing City Council candidate forum. The room was packed, all the candidates were present, the questions were fair, and volunteers made it happen (Joanne Winkelman in particular!). Dorothy Engelman did her usual great job moderating the program.

are plenty of strong opinions on the state of East Lansing. The forum gave citizens the opportunity to hear from candidates in an atmosphere free of rancor, one that assumed that all candidates deserve a fair hearing and offered just that. VOTER SERVICES UPDATES

About 70 citizens attended the September 14 forum for the East Lansing City Council candidates at the Hannah Center in East Lansing co-sponsored by East Lansing Info (ELi); all of the candidates participated. Volunteers included Judy Andre, Dorothy Engelman, Lisa Moore, Donna Mullins, Elaine Fischhoff, Jacqueline Stewart and Kathy Lovell. ELi and the <u>City Pulse</u> reported on the forum and Metro Melik provided the videotaping for the event. We will let you know when the recording is posted on our YouTube channel.



The Grand Ledge Library will hold a

registration event on September 25. Four local clerks agreed to be present to answer questions and register voters. Many thanks to League member John Hanieski for organizing the event. The Lansing City Clerk asked the LWVLA to assist with voter registration the week of September 18 at Lansing Community College. A message was sent to League members asking for volunteers.

Marilyn Wilson and I will be speaking to the adult education class at Lansing Schools during the lunch hour on September 26, addressing voting, the registration and voting processes, and where they can find information about candidates and/or ballot proposals. Registration opportunities will also be available.

Trunk or Treat will take place at the South Washington office of the Lansing City Clerk on October 28 from 1- 4 p.m. Lansing is piloting early voting so the polls will be open that day. The LWVLA will again have a table at the event. Volunteers have not yet been solicited. This is the event that everyone loves to be a part of!

We are planning a members-only virtual event to present the latest information on Michigan's new voting laws that were created as a result of Proposal 2 passing last November. The presentation was created by **Promote the Vote**. Another meeting, most likely in person, will be held after the first for those who are interested in helping to share this information with the greater community. Keep an eye out for an announcement soon. Next year we will be educating voters about the changes in addition to presidential-election-year events. EDUCATION COMMITTEE Bettie Landauer-Menchik, Committee Chair

The Education Committee hopes many LWVLA members and their friends will join us at the October 26 evening meeting with <u>Superintendent Ben Shuldiner</u> of the Lansing School District. Ben will share his vision and the strategic plan for Lansing Schools developed under his leadership. Ben is an activist leader and he is eager to have League members share their talents with the school district.

Ben came to Lansing from New York City, where he founded a highly successful charter school in 2003. At that time, he was the youngest high school principal in the state of New York. He ran for Congress in 2006 and lost in a close primary. In 2015, Ben was appointed to the New York City Board of Education, the largest school system in America.

In 2016 and 2017, Ben served as president of ASCD, the Association for Supervision and Curriculum Development. For his work in education, Ben was awarded the prestigious Jefferson Award for Public Service for an Individual 35 Years of Age and Under.

MICHIGAN -- DEAD LAST IN SEPTIC SYSTEMS INSPECTION Marion Gorton, EAG Member



Michigan is the only state of our 50 United States that fails to regulate the septic systems that serve homes and businesses. The task is left to individual counties, townships and local jurisdictions to set their own standards for construction, maintenance and inspection of septic systems. Only 11 of Michigan's 83 counties have adopted standards and requirements. Ingham County requires a "point of sale" inspection. Eaton and

Clinton counties have no inspection requirements.

The Bad News: Over one million septic systems serve the needs of 35 percent of Michigan residents. EGLE estimates that more than 330,000 of them are failing. Megan Tinsley of the Michigan Environmental Council says, "When a septic system fails, it leaks human wastes that carry pathogens into the ground. This pollution then makes its way to groundwater, lakes, streams, or even drinking water nearby. These threats have been documented by the state since at least the 1970s." Studies have shown that more than 9,000 miles of our Michigan streams exceed safe bacterial levels.

Great News: Bills have now been introduced in both the Michigan House of Representatives (<u>HB 4479</u> and <u>HB 4480</u>) and the Senate (<u>SB 299</u> and <u>SB 300</u>) to enact a state Septic Code. These bills would:

- require septic inspections every 5 years.
- establish a technical advisory commission to advise the state and local governments on implementation of the septic code.
- create a database to track inspections.
- provide funding to counties for establishment of the programs.

The Good News about Michigan's fresh water: According to the Department of Environment, Great Lakes and Energy, (EGLE), Michigan has over 36,000 miles of streams and more than 11,000 lakes and ponds. A 2018 report from the nonprofit For Love of Water (FLOW) states that the volume of groundwater in the Great Lakes watershed is "roughly equal to the volume of Lake Huron," calling it the "Sixth Great Lake."

What you can do: Governor Whitmer recently proclaimed September 18 – 22 SepticSmart Week. To learn more and find out what you can do, go to <u>EGLE's</u> <u>SepticSmart website</u>. Most important, contact your state representative and senator to encourage them to protect our Michigan waters.

ONE THING

Buying new things, especially tools like lawn mowers, ladders, drills and much more, is a cost to you *and* to the environment. The next time a project requires something you don't have, consider using a **tool library**. Lansing residents can access one at <u>Capital Area</u> <u>Housing</u>, while the <u>East Lansing Library</u> has one for its patrons. You can also share ownership with friends or neighbors or create your own neighborhood borrowing group.
