MESSAGE FROM THE PRESIDENT

For the Lansing Area League the month of July is generally a month for taking a break from League activities. It is meant to be a time for renewal, especially as we approach a busy fall voting season. Accordingly, we had a slower month than usual, but we still accomplished some important League work.



First, at least eleven League members participated in a Make Good Trouble Rally in Lansing on July 17. LWWUS was a partner in the event and, as a part of [Unite & Rise 8.5](#), local leagues were encouraged to attend.

The rally was sponsored by Bee Accepting, a “grassroots movement to protect people with disabilities, people of all colors and cultures as well as those in the LGBTQIA community.” Over 300 people gathered in the Ingham County Health Department parking lot. We stood along Cedar Street with our signs from 4-6 pm. The rally was well organized, and the intersection was busy that time of day.



The goal of the rally was to bring visibility to the cause (e.g., fighting cuts to SNAP and Medicaid, and threats to our democracy). The reception from those that passed by was extremely positive. I believe this type of demonstration has great merit. We had a very diverse audience, and we brought visibility to the League and to the resistance movement. I am confident that we will have the opportunity

to support these types of rallies in the future.

Second, along with the nonpartisan organization Michigan Country, we hosted several food, baby care products, and period products drives, which were then followed by community chats throughout Eaton County. These events were great opportunities to reach out to rural area citizens to promote voting and voter education. Third, we had

regular planning meetings for our upcoming events. These include more Lunch and Learns and candidate forums leading up to the November elections. Voter Services is also getting data together for VOTE411.org. Details will follow.

Finally, our two billboards that serve to draw attention to the threats to our democracy were, and are, still up! We feel incredibly fortunate that the sign company has kept our message up months past our contract date since they haven't had someone else wanting to rent them. I am very proud of these billboards and the role that they play in our efforts to support Unite & Rise 8.5.

Where did the summer go? Before we took a break in July, we had a great turnout at the Membership Luncheon on June 18. Two speakers from the Refugee Development Center and Samaritas spoke about the challenges they face in these difficult times. It was a heartbreaking discussion, because these organizations have a long history of successfully integrating refugees into our communities.



Moving forward, we have some exciting things in the works for our fall and winter programming.

First, the EAGers have arranged a tour of the Tollgate Wetlands on August 28 at 1 pm. One of Ingham County Drain Commissioner Pat Lindemann's many unique solutions to stormwater management, it features three ponds that clean the water as well as provide habitat for much wildlife. Second, on September 10, Maria Woloson will be giving the LWVUS presentation on eliminating the Electoral College at the **MSUFCU Headquarters Building 2 Community Room**. Observers for Eaton or Clinton Counties must observe in-person, but Ingham County provides on-line viewing for those who don't want to travel.

Once again the City of Lansing is holding their annual Halloween event during early voting. Defending democracy requires that we know what our governmental bodies are doing. We will have an easy reporting form so information can be shared with the volunteer group, LWVLA, and LWVMI. Please remember that we are NOT asking anyone to argue with elected officials or their fellow citizens, but merely to observe government in action.

DAILY DEMOCRACY PRACTICES AS A PART OF UNITE & RISE 8.5

LWVUS encourages members to do at least a few of these activities in the next month to help support democracy.

Civic Visibility & Education

1. Post voter registration deadlines or League events on your social media.
2. Wear your League pin, shirt, or tote bag in public to spark conversations.
3. Observe and share what you learn at a school board or city council meeting.
4. Share a photo of yourself volunteering with the League and tag your local League account.
5. Forward a League newsletter or action alert to three people and invite them to join the promoted activities.
6. Invite a neighbor or colleague to a League-sponsored voter education event.
7. Present an emerging local issue at your next League meeting for discussion.

Recruitment & Relationship Building

1. Ask one friend or family member to volunteer with you at the next League event.
2. Create a list of 5 people aligned with League values and personally invite them to a

- meeting.
3. Pair up with a newer member and guide them through their first volunteer experience.
 4. Host a coffee chat or Zoom meeting to introduce potential volunteers to the League.
 5. Share your personal “why I joined the League” story at a community gathering.
 6. Take photos at League events and tag participants (with permission) to amplify engagement.
 7. Keep a short League story ready to share when people ask about our work.

IMMIGRATION CONCERNS

If the subject stated above captures your interest, there is a discussion group you may want to join: the **LWVUS Immigration Discussion Group**. The LWVUS adopted a position on immigration in 2006 following an in-depth study and amid significant changes in federal policies in the wake of the 9-11 terrorist attacks. It is my understanding that the leadership team of this group is very knowledgeable, experienced and passionate in their support of the immigrant community, especially now.

The goal of this discussion group is to share information about the implementation of new immigration policies in our various states and localities. One area of interest is how undocumented immigrants who re-enter the U.S. are treated. Another is the legal process afforded to immigrants who have fled their homeland because of crime or gang violence.

Through this web forum, League members and partners can share research on immigration law and civil rights and the applications and implications of policies. Leagues can use these findings to educate their communities through general meetings, interviews with federal officials such as judges and U.S. attorneys, letters to the editor, Op-Eds, and informational articles for the media. Sharing our concerns, expertise and queries will help us to promote a greater understanding of democracy that is of the people, by the people, and for the people.

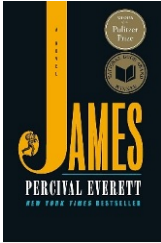

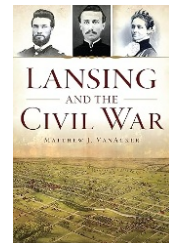

THREAT TO MICHIGAN'S BELOVED "PORKIES"

While the Environmental Advocacy Group took the summer off, the LWVMI Environmental Network, a consortium of environmentally concerned individuals representing Leagues across Michigan (including our own) led by Sandra Sorini-Elser, LWVMI's V.P.-Advocacy, hasn't remained quiet. Notes from their July meeting included a report on the proposed **Copperwood Mine** on Lake Superior in the Western U.P near the edge of Porcupine Mountain State Park. A May [story](#) in *Bridge* provides further details.

The park, which contains Michigan's largest mixed old-growth wilderness area, encompasses 30,000 acres of unlogged forest and is considered Michigan's most beautiful state park. The park was set aside in 1945 specifically to protect the area from mining and logging interests. This mine would be a copper-sulfide mine drilling beneath the park. There are sixteen compounds of environmental health concerns here, including mercury, lead, cadmium, and arsenic. Thus, the variety of environmental threats include toxic materials flowing down into Lake Superior.

A 323-acre waste facility would be near the Western boundary of the park. In full compliance with **permits**, a project like this will require clearcutting over 500 acres of forest, destroying 62 acres of wetlands, rerouting streams, and contaminating water. It would require 24-hour lighting, impose noise pollution, and introduce infrastructure like industrial roads, a power grid, and cell towers, which could permanently open the area to ongoing development. A \$50 million infrastructure grant has been requested from the state of Michigan from the Canadian mining company, in two different proposals, to prepare for construction of the \$450 million mine. The grant request has a **September 30th deadline** to get approved before expiring.

Those interested in more information or to express an opinion or *sign a petition* (as the constituent of your legislator, not as a League member) on the project or grant can go to protecttheporkies.com. The LWVMI has submitted a [letter in opposition](#) to the project. Please share this with others. Keep in mind Joni Mitchell's warning: "You don't know what you got 'till it's gone." Tell your legislators that Michigan's treasures must not be sold or destroyed.
